1. Continue the process of establishing and prioritizing a list of improvement projects to improve pedestrian safety in the City of Pacific Grove.

The Commissioners discussed the list of proposed pedestrian improvement sites that was put together at the first meeting of the sub committee. The following locations were deleted from the list and the reasons for deletion are noted:

1. Forest Avenue (State Hwy 68) @ David Avenue – *Intersection is signalized*
2. Pine Avenue @ Forest Avenue – *Existing traffic signals were recently updated*
3. Pine Avenue @ Congress Avenue – *Refer to Traffic Commission for 4 way stop consideration.*
4. Pacific Grove High School – *Flashing Crosswalk on Sunset Drive is operating*
5. Private Schools on David Avenue – *Appropriate school signs & markings installed.*
6. Sunset Avenue (Rte 68) @ Congress Avenue – *Recent changes to striping*
7. Central @ 8th Street – *Crosswalk on Central @ 9th was recently repainted*
8. Forest Ave (Rte 68) @ Morse Drive – *Exist. signalized intersection 1 block north.*
9. Junipero Avenue @ Forest Avenue – *Red Curb, refer to T.Commission*

The following locations were added to the list:

1. Jewell Ave @ Pacific Ave and Caledonia – *Pedestrian access provided to the park*
2. Forest Avenue @ Grove Market – *Improvements to existing crosswalk*

9. Dewey Avenue @ Central Avenue – *Crosswalk*
10. Forest Avenue (Rt 68) @ Forest Hill Boulevard – *Ped Assess recommendation*
11. Ocean View Ave Access to Recreation Trail – *Fountain, Grand & Forest, T calm*
12. Robert Down School – *12th & 13th Street Passenger Loading Zones*
13. Pacific Grove Middle School & Auditorium – *Forest Avenue concerns*
14. Forest Grove School – *Congress Ave Sidewalk*
15. Forest Avenue @ Sinex Avenue – *Traffic signal Upgrade*
16. David Avenue – *Congress Avenue westerly to end – Sidewalks*
17. Pine Avenue – *4 to 3 lane conversion*
18. Fountain Avenue @ Central Avenue – *Intersection Geometrics*
19. Jewell, Pacific & Caledonia – *Pedestrian Crossing across Jewell*
20. Forest Avenue crosswalk @ Grove Market – *Pedestrian Assess Recommendation*
