GENERAL RELEASE OF LIABILITY & ACKNOWLEDGEMENT OF
THE ASSUMPTION OF RISK OF INJURY**

In consideration for granting permission to participate in the **2007** California Police and Fire Games, hosted by the Pacific Grove Police Department and the California Police and Fire Games, Inc., in and around Pacific Grove, California during **April, 2007**, the undersigned, on behalf of the undersigned, and all heirs, successors, executors, administrators, next of kin and assigns (collectively "successors"), hereby fully release, discharge and hold harmless each and all Cities, Counties, Departments, Agencies, Corporations, Associations and all others involved in any way in the aforesaid **2007** California Police and Fire Games, and their members, directors, agents, employees, associates and staff from any and all claims, actions loss, damage and liabilities which said undersigned and/or any successors may now have or which may accrue to any of them against any of the aforementioned Cities, Counties, Departments, Agencies, Corporations or Associations, by reason of the undersigned's voluntary participation in any of the activities and events relating to the **2007** California Police and Fire Games.

The undersigned by participation, freely and voluntarily, expressly and impliedly, assumes the risk of death or any type of injury (including physical or emotional) (s)he may sustain including medical and hospital bill, permanent or partial disability, death and damage to any property and voluntarily waives any right(s) to any remedy against those released hereunder (s)he may have as a result of injury in addition to the above release.

The undersigned further agrees that prior to participating, (s)he will inspect the facilities and equipment to be used, and acknowledges hereby that (s)he understands that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from the actions or inactions of the participant, but also from the intentional or negligent acts of others, including but not limited to participating Cities, Counties, Departments, Agencies, Corporations or Associations, from the rules of play and their application, from the conditions of the premises and/or equipment, and from other causes now unknown or not now reasonably foreseeable.

The undersigned warrants that (s)he is in good health and has no physical condition preventing participation.

The undersigned acknowledges that (s)he executes this "General Release of Liability and Acknowledgement of Assumption of Risk of Injury" freely and voluntarily, and that (s)he does not rely on any inducements, promises or representations made by the aforementioned organizations, entities or individuals involved in the **2007** California Police and Fire Games, or of any person associated in any way therewith, and intend my signature to be a complete and unconditional release of liability to the greatest extent allowed by law.
